To be eligible for the 2020 Breeders' Cup World Championships held at Keeneland on November 6 and 7, 2020, all horses must be pre-entered by noon (local standard time at the designated place of pre-entry) on Monday, October 26, 2020. Winner must be nominated by pre-entry deadline to receive Challenge rewards. All Challenge winners are subject to out-of-competition testing by the Kentucky Horse Racing Commission and/or BCL. All runners are subject to out-of-competition testing by the Kentucky Horse Racing Commission and/or BCL. Breeders' Cup Limited reserves the right in its sole discretion to postopone, discontinue, amend or change the conditions of all or any part of the Breeders' Cup Challenge "Win and You're In" race program. Certain finishing positions in this race will earn points to qualify for the 2021 Kentucky Oaks, pursuant to the official rules for the Kentucky Oaks published by Churchill Downs Incorporated.
