

## 90th Running Of The Ben Ali \$150,000

**FOR FOUR YEAR OLDS AND UPWARD** By subscription of \$100 each, which should accompany the nomination or by Supplementary Nomination of \$4,500 at time of entry (includes entry and starting fees). \$750 to enter and an additional \$750 to start, with \$150,000 guaranteed, of which \$90,000 to the owner of the winner, \$30,000 to second, \$15,000 to third, \$7,500 to fourth, \$4,500 to fifth and \$3,000 to be divided equally among sixth through last. Weight: 123 lbs. Non-winners of a Grade I stakes over a mile since November 3, allowed 3 lbs.; a Grade II stakes over a mile since October 2, 5 lbs. The maximum number of starters for the Ben Ali will be limited to fourteen with two also eligible. In the event that more than fourteen pass the entry box, the fourteen starters will be determined at that time with preference given to graded stakes winners (in order I-II-III), then highest earnings in 2020-2021. Starters to be named through the entry box by the usual time of closing. Keeneland will present a trophy cup to the FILID CALCE.
