FOR FILLIES AND MARES, THREE YEARS OLD AND UPWARD By subscription of \$10,500 by time of entry (Includes entry and starting fees). \$1,750 to enter and an additional \$1,750 to start, with \$350,000 guaranteed, of which \$210,000 to the owner of the winner, \$70,000 to second, \$35,000 to third, \$17,500 to fourth, \$10,500 to fifth and \$7,000 to be divided equally among sixth through last. Weight: Three year old fillies, 121 lbs.; Older fillies and mares, 124 lbs. The First Lady has been selected as one of the Breeders' Cup "Win and You're In" Challenge Races. The nominated winner of the First Lady will be entitled to automatic entry into the 2020 running of the Breeders' Cup Filly & Mare Turf pre-entry and entry fees waived for the Breeders' Cup Filly & Mare Turf or will receive a credit equal to the Breeders' Cup Filly & Mare Turf pre-entry and entry fee amount towards any other Breeders' Cup World Championship race, and all horses will be entitled to receive a travel stipend if traveling from a base located outside the state of Kentucky. To be eligible for the 2020 Breeders' Cup World Championships held at Keeneland on November 6 and 7, 2020, all horses must be pre-entered by noon (local standard time at the designated place of pre-entry) on Monday, October 26, 2020. Winner must be nominated by pre-entry deadline to receive Challenge revards. In the event this race is taken off the turf' race will NOT receive an automatic qualifying position and will NOT receive the starting fees (the total of pre-entry and entry fees) to enter the Breeders' Cup World Championships in the applicable Turf Division race, provided, however, that Breeders' Cup Limited may, at its option, reinstate the "Win and You're In" status of the "off the turf" race.
