FOR THREE YEAR OLDS AND UPWARD By subscription of \$100 each, which should accompany the nomination or by Supplementary Nomination of \$4,500 by time of entry (Includes entry and starting fees). \$750 to enter and an additional \$750 to start with \$150,000 guaranteed, of which \$90,000 to the owner of the winner, \$30,000 to second, \$15,000 to third, \$7,500 to fourth, \$4,500 to fifth and \$3,000 to be divided equally among sixth through last. Weight: Three year olds, 122 lbs.; Older, 125 lbs. Non-winners of a Grade I or II over ten furlongs on the turf in 2021 allowed 2 lbs.; a graded stakes over nine furlongs in 2021, 4 lbs. The maximum number of starters for the Sycamore will be limited to fourteen, with two also eligibles. If this race is transferred to the main track the field will be limited to fourteen. In the event that the race overfills the starters will be determined at that time with preference given to graded or group stakes winners over nine furlongs (in order I-II-III), stakes winners over nine furlongs, then highest non-restricted turf earnings in 2021. Starters to be named through the entry box by the usual time of closing. (If this race is taken off the turf it will be downgraded one grade level for this running only in accordance with American Graded Stakes Committee policy). A Keeneland trophy cup will be presented to the owner of the winner.
