The Appalachian Presented by Japan Racing Association
\$500,000
(Grade II)**

(Includes \$100,000 from KTDF)

FOR FILLIES, THREE YEARS OLD By subscription of \$100 each, which should accompany the nomination or by Supplementary Nomination of \$8,000 at time of entry (includes entry and starting fees). \$2,000 to enter and an additional \$2,000 to start, with \$400,000 guaranteed plus an additional \$100,000 KTDF for KTDF eligible horses. After payment of 1.25% to each owner of horses finishing sixth through last, 62% of the remaining association purse will be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth. KTDF funds correspondingly divided providing a KTDF eligible horse finishes in an award position. Weight: 123 lbs. Non-winners of a Grade I stakes at a mile or over on the turf allowed 3 lbs.; a Grade II stakes at a mile or over on the turf, 5 lbs. The maximum number of starters for the Appalachian presented by the Japan Racing Association will be limited to twelve with four also eligibles. In the event that more than twelve fillies pass the entry box, the twelve starters will be determined at that time with preference given to graded stakes winners (in order I-II-III), graded stakes placed (in order I-II-III), non-restricted stakes winners on turf or synthetic, then highest earnings. Starters to be named through the entry box by the usual time of closing. The winner of the 2025 Appalachian will get an automatic invitation to the 2025 Grade I Queen Elizabeth Challenge Cup in October. Keeneland will present a trophy cup to the winning owner. (If this race is taken off the turf it will be downgraded one grade level for this running only in accordance with American Graded Stakes Committee policy).
