FOR FILLIES THREE YEARS OLD By subscription of \$100 each on or before February 18, 2026 or \$1,000 each on or before March 18, 2026. A Supplementary Nomination of \$12,000 each may be made at time of entry (includes entry and starting fees). \$3,000 to enter and an additional \$3,000 to start, with \$600,000 guaranteed plus an additional \$150,000 KTDF for KTDF eligible horses. After payment of 1.25% to each owner of horses finishing sixth through last, 62% of the remaining association purse will be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth. KTDF funds correspondingly divided providing a KTDF eligible horse finishes in an award position. The winner will earn 100 Road To The Kentucky Oaks Points, second will earn 50 Road To The Kentucky Oaks Points, third will earn 25 Road To The Kentucky Oaks Points, fourth will earn 15 Road To The Kentucky Oaks Points and fifth will earn 10 Road To The Kentucky Oaks points. Weight: 121 lbs. The maximum number of starters for the Central Bank Ashland will be limited to twelve with four also eligible. In the event that more than twelve pass the entry box, the twelve starters will be determined at that time with preference given to graded stakes winners (in order I-II-III), graded stakes placed (in order I-II-III), then highest earnings. Graded Stakes races that were run while the subject horse was administered Lasix will NOT be considered for preference. Starters to be named through the entry box by the usual time of closing. Keeneland will present a trophy cup to the winning owner. A silver julep cup will be presented to the winning trainer and jockey.
