Section 17. Entry Examination by Attending Veterinarian.
(1) A horse shall only start if: (a) The horse has been examined by an attending veterinarian licensed by the veterinary regulatory body in the jurisdiction where the examination occurs within three (3) days after the close of entries and no later than two (2) days before the race; and (b) The attending veterinarian certifies and electronically submits a report to the Equine Medical Director or its designee that the horse is in serviceable, sound racing condition.

MAIN TRACK: 5:30am-10am (two breaks, 7-7:30 and 8:30-9) reserved timed work window 10 mins after each break.
TRAINING TRACK: 5:30am-11am (no breaks).
GATE SCHOOLING: Tuesday-Sunday 6:30am-9:30am on the Main Track (Closed Mondays). Gate closes promptly at 6:50AM and 8:20AM prior to each renovation break.

Trainers who wish to enter a horse at Keeneland are required to complete the following: Trainer/Vet Agreement: A 2026 agreement signed by both the trainer and his/her attending veterinarian must be on file at Keeneland. Signed agreements can be emailed to SBrown@keeneland.com.

Entry Restrictions: Pursuant to the Regulations, trainers of all first-time starters four years of age or older and any horses that have not raced in the previous 365 days are required to (i) contact a KHRGC Veterinarian to schedule an official work(s) and (ii) ensure that all such horses are approved by such KHRGC Veterinarian PRIOR to entry. Please consult the KHRGC Rules for further information. In addition, any first-time starter (a) four years old or older or (b) three years old or older that has not raced in the previous 365 days shall have an exam and published five (5) furlong work in 1:03:00 or faster approved by the Keeneland Vice President of Equine Safety (or his or her designee) PRIOR to entry. Finally, Keeneland's Vice President of Equine Safety (or his or her designee) may require a previously raced horse that has not raced within 150 days but has raced within 365 days to be evaluated PRIOR to entry and in addition any such horse must meet all other applicable regulatory requirements. Following regulatory veterinarian clearance for a horse who has not started in the previous 365 days OR a horse four years or older that is a first-time starter, the horse has 60 days in which to start or it will be required to work again for the regulatory veterinarian with blood drawn to regain eligibility. Any unstarted horse six (6) years old or older shall not be permitted to stable, race, work or train at any Keeneland or TTC Facility unless approved in advance by the Keeneland Vice President of Equine Safety or his/her authorized designee. Trainer will also not enter in a race: (a) any horse that has finished twelve (12) or more lengths behind the winner in each of its last five (5) consecutive starts, or (b) any horse that has raced greater than four (4) times in the fifty-six (56) days immediately preceding the race date.

KEENELAND RACE SHUTTLE: Sallee will provide daily shuttle service to Keeneland from Churchill Downs, Trackside and The Thoroughbred Center.
