The Bewitch Presented by Keeneland Sales
\$350,000
(Grade III)
(Includes \$100,000 from KTDF)**

FOR FILLIES AND MARES, FOUR YEARS OLD AND UPWARD By subscription of \$100 each, which should accompany the nomination or by Supplementary Nomination of \$5,000 at time of entry (includes entry and starting fees). \$1,250 to enter and an additional \$1,250 to start, with \$250,000 guaranteed plus an additional \$100,000 KTDF for KTDF eligible horses. After payment of 1.25% to each owner of horses finishing sixth through last, 62% of the remaining association purse will be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth. KTDF funds correspondingly divided providing a KTDF eligible horse finishes in an award position. Weight: 123 lbs. Non-winners of a Grade I over nine furlongs on the turf since October 4, allowed 3 lbs.; a graded stakes over nine furlongs since August 1, 5 lbs. The maximum number of starters for the Bewitch Presented by Keeneland Sales will be limited to twelve with four also eligibles. In the event that more than twelve fillies or mares pass the entry box, the twelve starters will be determined at that time with preference given to graded stakes winners (in order I-II-III), then highest earnings in 2024-2025. Starters to be named through the entry box by the usual time of closing. Keeneland will present a trophy cup to the winning owner. (If this race is taken off the turf it will be downgraded one grade level for this running only in accordance with American Graded Stakes Committee policy).
