"Win and You're In Breeders' Cup Juvenile Division"

FOR TWO YEAR OLDS By subscription of \$150 each, which should accompany the nomination or by Supplementary Nomination of \$10,000 by time of entry (Includes entry and starting fees). \$2,500 to enter and an additional \$2,500 to start with \$500,000 guaranteed plus an additional \$150,000 KTDF for KTDF eligible horses. After payment of 1.25% to each owner of horses finishing sixth through last, 62% of the remaining association purse will be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth. KTDF funds correspondingly divided providing a KTDF eligible horse finishes in an award position. Weight: Fillies, 119 lbs.; Colts and Geldings, 122 lbs. The Claiborne Breeders' Futurity has been selected as one of the Breeders' Cup "Win and You're In" Challenge Races. The nominated winner of the Claiborne Breeders' Futurity will be entitled to automatic entry into the 2025 running of the Breeders' Cup Breeders' Cup Juvenile Division. The nominated winner will also be entitled to have pre-entry and entry fees waived for the 2025 Breeders' Cup Juvenile or will receive a credit equal to the Breeders' Cup Juvenile pre-entry and entry fee amount towards any other 2025 Breeders' Cup Championship race. All horses will be entitled to receive a travel stipend if traveling from a base located outside the state of California. To be eligible for the 2025 Breeders' Cup World Championships held at Del Mar on October 31 and November 1, 2025, all horses must be pre-entered by noon (local standard time at the designated place of pre-entry) on Monday, October 20, 2025. Winner must be nominated by pre-entry deadline to receive Challenge rewards. All Breeders' Cup Challenge Races and Breeders' Cup World Championship races are to be run Lasix free and in accordance with Breeders' Cup Limited rules as they may be published and/or amended from time to time, which rules are hereby expressly incorporated by this reference. All runners nominated to Challenge races and all Challenge winners are subject to out-of-competition testing by HIWU on behalf of HISA (or their respective designees). Breeders' Cup Limited reserves the right in its sole discretion to postpone, discontinue, amend, or change the conditions of all or any part of the Breeders' Cup Challenge "Win & You're In" race program. The maximum number of starters for the Claiborne Breeders' Futurity will be limited to twelve with four also eligibles. In the event that more than twelve horses pass the entry box, the twelve starters will be determined at that time by horses that have finished first, second or third in a graded stakes, non-restricted stakes winners then condition preference. Graded Stakes races that were run while the subject horse was administered Lasix will NOT be considered for preference. Starters to be named through the entry box by the usual time of closing. A Keeneland trophy cup will be presented to the owner of the winner. A silver julep cup will be presented to the winning trainer and jockey. The first four finishers in the Claiborne Breeders' Futurity will automatically be nominated to the 2026 Toyota Blue Grass Stakes, as far as nomination fee.
