FOR THREE YEAR OLDS AND UPWARD By subscription of \$100 each which should accompany the nomination or by Supplementary Nomination of \$6,000 by time of entry (Includes entry and starting fees). \$1,500 to enter and an additional \$1,500 to start, with \$250,000 guaranteed plus an additional \$100,000 KTDF for KTDF eligible horses. After payment of 1.25% to each owner of horses finishing sixth through last, 62% of the remaining association purse will be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth. KTDF funds correspondingly divided providing a KTDF eligible horse finishes in an award position. Weight: Three year olds, 122 lbs.; Older 126 lbs. Non-winners of a Grade I over a mile in 2025, allowed 2 lbs.; Grade II over a mile in 2025 or two Grade III stakes at a mile or over in 2025 allowed 4 lbs. The maximum number of starters for Hagyard Fayette will be limited to twelve with four also eligibles. In the event that more than twelve horses pass the entry box, the twelve starters will be determined at that time with preference to graded or group stakes winners (in order I-II-III), graded or group stakes placed (in order I-II-III) then non-restricted stakes winners at a mile or over in 2024-2025. Graded Stakes races that were run while the subject horse was administered Lasix will NOT be considered for preference. Starters to be named through the entry box by the usual time of closing. A Keeneland trophy cup will be presented to the owner of the winner.
