FOR FILLIES AND MARES, THREE YEARS OLD AND UPWARD By subscription of \$150 each, which should accompany the nomination or by Supplementary Nomination of \$13,000 by time of entry (Includes entry and starting fees). \$3,250 to enter and an additional \$3,250 to start, with \$650,000 guaranteed plus an additional \$150,000 KTDF for KTDF eligible horses. After payment of 1.25% to each owner of horses finishing sixth through last, 62% of the remaining association purse will be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth. KTDF funds correspondingly divided providing a KTDF eligible horse finishes in an award position. Weight: Three year old fillies, 121 lbs.; Older fillies and mares, 125 lbs. The maximum number of starters for the First Lady will be limited to twelve, with four also eligibles. In the event that the race overfills the starters will be determined at that time with preference given to graded or group stakes winners on the turf (in order I-II-III), graded or group stakes placed (in order I-II-III), non-restricted stakes winners on the turf in 2026, then condition preference. Graded Stakes races that were run while the subject horse was administered Lasix will NOT be considered for preference. Starters to be named through the entry box by the usual time of closing. (If this race is taken off the turf it will be downgraded one grade level for this running only in accordance with American Graded Stakes Committee policy). A Keeneland trophy cup will be presented to the owner of the winner. A silver julep cup will be presented to the winning trainer and jockey.
