FOR FILLIES AND MARES, THREE YEARS OLD AND UPWARD By subscription of \$100 each, which should accompany the nomination or by Supplementary Nomination of \$5,000 by time of entry (Includes entry and starting fees). \$1,250 to enter and an additional \$1,250 to start, with \$300,000 guaranteed plus an additional \$100,000 KTDF for KTDF eligible horses. After payment of 1.25% to each owner of horses finishing sixth through last, 62% of the remaining association purse will be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth. KTDF funds correspondingly divided providing a KTDF eligible horse finishes in an award position. Weight: Three year olds, 122 lbs.; Older 125 lbs.; Non-winners of a Grade I or II sweepstakes on the turf in 2025, allowed 2 lbs.; a graded sweepstakes in 2025, 4 lbs. The maximum number of starters for the Franklin will be limited to twelve with four also eligibles. In the event that the race overfills the starters will be determined with preference given to graded stakes winners (in order I-II-III), graded stakes placed (in order I-II-III), then non-restricted stakes winners on the turf or synthetic in 2025. Graded Stakes races that were run while the subject horse was administered Lasix will NOT be considered for preference. Starters to be named through the entry box by the usual time of closing. (If this race is taken off the turf it will be downgraded one grade level for this running only in accordance with American Graded Stakes Committee policy). A Keeneland trophy cup will be presented to the owner of the winner.
