2025 November Breeding Stock Sale

Sale begins November 4th

Entry Fee & Commission Structure

The entry fee for all Keeneland sales is \$1,000. The sales commission will be 5% on bids exceeding \$10,000 with a minimum commission of \$500 per sale. The RNA commission will be 2.5% on bids exceeding \$10,000. See below for examples of this structure at different price points:

FRIDAY, AUGUST 1

- ☐ Final entries due online

WEDNESDAY, AUGUST 6

- ☐ Property line changes

SUNDAY, AUGUST 10

- ☐ Racing Updates (races run after this date will not appear in catalog)

MONDAY, AUGUST 11

- ☐ Breeders' Cup, EBF and State-bred nominations due into their respective offices in order to appear in the sales catalog

FRIDAY, AUGUST 15

- ☐ Final withdrawal to not appear in catalog (second \$500 entry fee waived)
- ☐ Wish lists due in Keeneland Sales Portal

WEDNESDAY, AUGUST 20

- ☐ Registration Certificates (paper or electronic) for all horses except weanlings (\$100 penalty per horse will apply after this date)

FRIDAY, AUGUST 29

- ☐ Preliminary placements released in Keeneland Sales Portal
- ☐ NTRA contribution lists

MONDAY, SEPTEMBER 1

- ☐ Black-type Racing Updates (races that run after this date will not appear in the catalog)

TUESDAY, SEPTEMBER 2

- ☐ Deadline to request session swaps in Keeneland Sales Portal
- ☐ First \$500 of Entry Fee

WEDNESDAY, SEPTEMBER 3

- ☐ Proof page changes
- ☐ Consignors' client lists for catalog mailing

WEDNESDAY, OCTOBER 1

- ☐ Original Color Coggins (\$100 penalty per horse will apply after this date)
- ☐ EVA results dated within 90 days of horses' sale date. Recommended blood pull Aug. 18 - Sept. 3, 2025 (\$100 penalty per horse will apply after this date)
- ☐ Digital Registration Certificates assigned to Keeneland Association, Inc. for all weanlings (\$100 penalty per horse will apply after this date)
- ☐ Stallion Service Certificates (paper or electronic) (\$100 penalty per horse will apply after this date.)
- ☐ Consignor's Authorized Agent forms (\$100 penalty per property line will apply after this date)

TUESDAY, OCTOBER 14

- ☐ First day to pull radiographs

REMINDER: All broodmares or broodmare prospects must have a veterinary certificate on file stating "pregnant" or "suitable for mating." Veterinary certificates must be dated within 10 days of selling date. Health Certificates must be dated within 30 days of arrival on sale grounds and are required in our office before they can sell.
