### COGGINS\*

- Results must be dated **within six (6) months** of horses' sale date and valid for two weeks after sale date.
- Keeneland must obtain original or scanned (PDF) **in color** Coggins.
- Photo copies or pictures taken from a phone are **not acceptable**, unless sent directly to Keeneland from a licensed veterinarian, clinic or lab.

- Results must be dated **within 90 days** of horses' sale date.

**November Breeding Stock Sale (Aug. 18 - Sept. 3)**  
**November Horses of Racing Age Sale (September)**  
**January Horses of All Ages Sale (Oct. 20 - Nov. 5)**  
**April Selected Horses of Racing Age Sale (March 2026)**

### HEALTH CERTIFICATE/CERTIFICATE OF VETERINARY INSPECTION (CVI)

- All horses must be accompanied by a Health Certificate which has been signed and dated **within 30 days** of arrival to Keeneland by a licensed veterinarian.
- All horses must be vaccinated against Equine Herpes Virus Type 1 (EHV-1) by a licensed veterinarian within a minimum of 14 days and no more than 120 days prior to entry into our stable area.
- Must indicate the date and product of the EHV-1 vaccination.

- All broodmares or broodmare prospects must have a veterinary certificate on file stating pregnant or suitable for mating.
- Veterinarian certificates must be dated within **10 days of selling date**.
