FOR THREE YEAR OLDS By subscription of \$150 each, which should accompany the nomination or by Supplementary Nomination of \$6,000 at time of entry (includes entry and starting fees). \$1,500 to enter and an additional \$1,500 to start, with \$300,000 guaranteed plus an additional \$100,000 KTDF for KTDF eligible horses. After payment of 1.25% to each owner of horses finishing sixth through last, 62% of the remaining association purse will be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth. KTDF funds correspondingly divided providing a KTDF eligible horse finishes in an award position. The winner will earn 20 Road To The Kentucky Derby Points, second will earn 10 Road To The Kentucky Derby Points, third will earn 6 Road To The Kentucky Derby Points, fourth will earn 4 Road To The Kentucky Derby Points and fifth will earn 2 Road To The Kentucky Derby Points. Weight: 123 lbs. The maximum number of starters for the Stonestreet Lexington will be limited to twelve with four also eligible. In the event that more than twelve pass the entry box, the twelve starters will be determined at that time with preference given to graded stakes winners (in order I-II-III), graded stakes placed (in order I-II-III), then highest earnings. Graded Stakes races that were run while the subject horse was administered Lasix will NOT be considered for preference. Starters to be named through the entry box by the usual time of closing. Keeneland will present a trophy cup to the owner of the winner.
