FOR FILLIES, TWO YEARS OLD By subscription of \$100 each, which should accompany the nomination or by supplementary nomination of \$3,000 by time of entry (includes entry and starting fees). \$750 to enter and an additional \$750 to start with \$175,000 guaranteed plus an additional \$75,000 KTDF for KTDF eligible horses. After payment of 1.25% to each owner of horses finishing sixth through last, 62% of the remaining association purse will be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth. KTDF funds correspondingly divided providing a KTDF eligible horse finishes in an award position. Weight 122 lbs. Non-winners of a graded sweepstakes allowed 2 lbs.; a sweepstakes, 4 lbs. The maximum number of starters for the Dean Dorton Myrtlewood will be limited to twelve. In the event that more than twelve horses pass the entry box, the twelve starters will be determined at that time by horses that have finished first, second or third in a graded or group stakes, non-restricted stakes winners, then condition preference. Graded Stakes races that were run while the subject horse was administered Lasix will NOT be considered for preference. Starters to be named through the entry box by the usual time of closing. A set of two silver julep cups will be presented to the owner of the winner.
