FOR FILLIES, THREE YEARS OLD By subscription of \$100 each, which should accompany the nomination or by Supplementary Nomination of \$6,000 by time of entry (Includes entry and starting fees). \$1,500 to enter and an additional \$1,500 to start, with \$300,000 guaranteed plus an additional \$100,000 KTDF for KTDF eligible horses. After payment of 1.25% to each owner of horses finishing sixth through last, 62% of the remaining association purse will be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth. KTDF funds correspondingly divided providing a KTDF eligible horse finishes in an award position. Weight: 123 lbs. Non-winners of a Grade I in 2025 allowed 3 lbs.; a Grade II or two Grade III stakes in 2024-2025, 5 lbs. The maximum number of starters for the Lexus Raven Run will be limited to twelve with four also eligibles. In the event that more than twelve fillies pass the entry box, the twelve starters will be determined at that time with preference to graded stakes winners (in order I-II-III), graded stakes placed (in order I-II-III), non-restricted stakes winners then condition preference. Graded Stakes races that were run while the subject horse was administered Lasix will NOT be considered for preference. Starters to be named through the entry box by the usual time of closing. A Keeneland trophy cup will be presented to the owner of the winner.
