



## 70th Running Of The Juddmonte Spinster "Win and You're In Breeders' Cup Distaff Division" \$650,000 (Grade I)



(Includes \$150,000 from KTDF)

(Includes \$150,000 by time of entry (Includes entry and starting fees). \$2,500 to enter and an additional \$2,500 to start, with \$500,000 guaranteed plus an additional \$150,000 KTDF feligible horses. After payment of 1.25% to each owner of horses finishing sixth through last, 62% of the remaining association purse will be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth. KTDF funds correspondingly divided providing a KTDF eligible horse finishes in an award position. Weight: Three year old fillies, 121 lbs.; Older, 125 lbs. The Juddmonte Spinster has been selected as one of the Breeders' Cup "Win and You're In" Challenge Races. The nominated winner of the Juddmonte Spinster will be entitled to automatic entry into the 2025 running of the Breeders' Cup Distaff Division. The nominated winner will also be entitled to automatic entry into the 2025 running of the Breeders' Cup Distaff Division. The nominated winner will also be entitled to have pre-entry and entry fees waived for the 2025 Breeders' Cup Distaff or will receive a credit equal to the Breeders' Cup Distaff pre-entry and entry fee amount towards any other 2025 Breeders' Cup World Championship held at Del Mar on October 31 and November 1, 2025, all horses must be pre-entered by noon (local standard time at the designated place of pre-entry) on Monday, October 20, 2025. Winner must be nominated by pre-entry deadline to receive Challenge rewards. All Breeders' Cup Challenge Races and Breeders' Cup World Championship races are to be run Lasix free and in accordance with Breeders' Cup Limited rules as they may be published and/or amended from time to time, which rules are hereby expressly incorporated by this reference. All runners nominated to Challenge races and all Challenge winners are subject to out-of-competition testing by HIWU on behalf of HISA (or their respective designees). Breeders' Cup Limited reserves the right in its sole discretion to postpone, discontinue, amend, or change the conditions of all or any par
