FOR THREE YEAR OLDS By subscription of \$200 each on or before February 18, 2023 or \$1,000 each on or before March 22, 2023. A Supplementary Nomination of \$17,000 each may be made at time of entry (includes entry and starting fees). \$4,250 to enter and an additional \$4,250 to start, with \$850,000 guaranteed plus an additional \$150,000 KTDF for KTDF eligible horses. After payment of 1.25% to each owner of horses finishing sixth through last, 62% of the remaining association purse will be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth. KTDF funds correspondingly divided providing a KTDF eligible horse finishes in an award position. The winner will earn 100 Road To The Kentucky Derby Points, second will earn 40 Road To The Kentucky Derby Points, third will earn 30 Road To The Kentucky Derby Points, fourth will earn 20 Road To The Kentucky Derby Points and fifth place will earn 10 Road To The Kentucky Derby Points. Weight: 123 lbs. The maximum number of starters for the Toyota Blue Grass will be limited to twelve with four also eligible. In the event that more than twelve pass the entry box, the twelve starters will be determined at that time with preference given to graded stakes winners (in order I-II-III), then highest earnings. Starters to be named through the entry box by the usual time of closing. Keeneland will present a trophy cup to the winning owner. A silver julep cup will be presented to the winning trainer and jockey.
