FOR THREE YEAR OLDS By subscription of \$100 each, which should accompany the nomination or by Supplementary Nomination of \$10,000 at time of entry (includes entry and starting fees). \$2,500 to enter and an additional \$2,500 to start, with \$500,000 guaranteed plus an additional \$100,000 KTDF for KTDF eligible horses. After payment of 1.25% to each owner of horses finishing sixth through last, 62% of the remaining association purse will be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth. KTDF funds correspondingly divided providing a KTDF eligible horse finishes in an award position. Weight: 123 lbs. Non-winners of a Grade I stakes at a mile or over on the turf allowed 3 lbs.; a Grade II stakes on the turf, 5 lbs. The maximum number of starters for the UK HealthCare Transylvania will be determined at the time of entry dependent on rail placement. In the event that this race overfills the starters will be determined at that time with preference to graded stakes winners (in order I-II-III), graded stakes placed (in order I-II-III), non-restricted stakes winners on turf or synthetic, then highest earnings. Graded Stakes races that were run while the subject horse was administered Lasix will NOT be considered for preference. Starters to be named through the entry box by the usual time of closing. Keeneland will present a trophy cup to the winning owner. (If this race is taken off the turf it will be downgraded one grade level for this running only in accordance with American Graded Stakes Committee policy).
