FOR THREE YEAR OLDS AND UPWARD By subscription of \$200 each, which should accompany the nomination or by Supplementary Nomination of \$20,000 by time of entry (Includes entry and starting fees). \$5,000 to enter and an additional \$5,000 to start with \$1,000,000 guaranteed plus an additional \$250,000 KTDF for KTDF eligible horses. After payment of 1,25% to each owner of horses finishing sixth through last, 62% of the remaining association purse will be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth. KTDF funds correspondingly divided providing a KTDF eligible horse finishes in an award position. Weight: Three year olds, 122 lbs.; Older, 126 lbs. The Coolmore Turf Mile as been selected as one of the Breeders' Cup "Win and You're In" Challenge Races. The nominated winner of the Coolmore Turf Mile will be entitled to automatic entry into the 2025 running of the Breeders' Cup Mile Division. The nominated winner will also be entitled to have pre-entry and entry fees amount towards any other 2025 Breeders' Cup Championships race. All horses will be entitled to receive a travel stipend if traveling from a base located outside the state of California. To be eligible for the 2025 Breeders' Cup World Championships held at Del Mar on October 31 and November 1, 2025, all horses must be pre-entered by noon (local standard time at the designated place of pre-entry) on Monday, October 20, 2025. Winner must be nominated by pre-entry deadline to receive Challenge rewards. All Breeders' Cup Challenge Races and Breeders' Cup World Championship races are to be run Lasix free and in accordance with Breeders' Cup Limited rules as they may be published and/or amended from time to time, which rules are hereby expressly incorporated by this reference. All runners nominated to Challenge races and all Challenge winners are subject to out-of-competition testing by HIWU on behalf of HISA (or their respective designees).
