A Supplementary Nomination of \$12,000 each may be made at time of entry (includes entry and starting fees). \$2,000 to enter and an additional \$2,000 to start, with \$400,000 guaranteed, of which \$240,000 to the owner of the winner plus 100 Road To The Kentucky Oaks Points, \$80,000 to second plus 40 Road To The Kentucky Oaks Points, \$40,000 to third plus 20 Road To The Kentucky Oaks Points, \$20,000 to fourth plus 10 Road To The Kentucky Oaks Points, \$12,000 to fifth and \$8,000 to be divided equally among sixth through last. Weight: 121 lbs. The maximum number of starters for the Central Bank Ashland will be limited to fourteen with two also eligible. In the event that more than fourteen pass the entry box, the fourteen starters will be determined at that time with preference given to graded stakes winners (in order I-II-III), then highest earnings. Starters to be named through the entry box by the usual time of closing. Keeneland will present a trophy cup to the winning owner. A silver julep cup will be presented to the winning trainer and jockey.
