Weight: 123 lbs. The maximum number of starters for the Toyota Blue Grass will be limited to fourteen. In the event that more than fourteen pass the entry box, the fourteen starters will be determined at that time with preference given to graded stakes winners (in order I-II-III), then highest earnings. Starters to be named through the entry box by the usual time of closing. Keeneland will present a trophy cup to the winning owner.
