- ☐ Property line changes in Sales Office—mhunter@keeneland.com
- ☐ Final withdrawal not to appear in catalogue
- ☐ Breeders' Cup, EBF and KTDF nominations due into their respective offices in order to appear in the sales catalogue
- ☐ NTRA contribution lists in Sales Office
- ☐ Original DIGITAL Coggins certificates emailed to mjohnson@keeneland.com in Sales Office
 - Coggins results must be dated within 12 months of date of sale.
- ☐ Original DIGITAL EVA results emailed to mjohnson@keeneland.com in Sales Office
 - EVA results must be dated within 90 days of date of sale and valid until July 7.
 - Each positive or suspicious EVA form must contain a titer reading
- ☐ All horses must be vaccinated against Equine Herpes Virus Type 1 (EHV-1) by a licensed veterinarian a minimum of fourteen (14) days and no more than one hundred and twenty (120) days prior to sale date. Proof of vaccination date and product used must be emailed to mjohnson@keeneland.com
- ☐ Copy of Jockey Club Registration certificates emailed to sboots@keeneland.com in Sales Office
 - Email must include LOCATION of original certificates
- ☐ Consignor's Authorized Agent form emailed to mhunter@keeneland.com in Sales Office
 - Keeneland must have an owner's signature on file for every consigned horse in the sale.
 - One partner's signature is sufficient for all partners.
 - Form must be filled out completely.
 - All forms must be notarized.
- ☐ All announcements, including cribbers and ridglings, uploaded

SATURDAY, JUNE 13 – FRIDAY, JUNE 19

- ☐ X-rays to Repository: Must be taken within 10 days of sale date.
 - X-rays, endoscopic videotapes and veterinary certificates must be on file in the Repository at least four days prior to sale date.
 - Veterinarians need to reach out to awhalen@keeneland.com for directions to upload x-rays into the repository.

Please note—if a horse is consigned by an agent, the agent is responsible for supplying all necessary documents (forms, certificates, test results, etc.) to Keeneland pursuant to the consignor's contract. We appreciate your cooperation with this.
