



QUICK REFERENCE GUIDE

Keeneland November Breeding Sale

Sale begins November 5, 2018

ENTRY FEE AND COMMISSION STRUCTURE

The entry fee for all Keeneland sales is \$1,000. The sales commission will be 5% on bids exceeding \$10,000 with a minimum commission of \$500 per sale. The RNA commission will be 2.5% on bids exceeding \$10,000. See below for examples of this structure at different price points:

NOVEMBER SALE DEADLINES

August 1

- Entries in Sales Office
- Withdrawal for full entry fee credit
- Breeders' Cup nominations due to Breeders' Cup office in order to appear on catalogue page
- KTOB registration due with KTOB office in order to appear in catalogue

August 3

- Property line changes due in Sales Office

August 17 - September 7

- Blood samples for E.V.A. blood testing have to be submitted to the lab within 90 days of the date of sale. We suggest you submit blood to the lab within this time period in order to avoid a rush on the lab.

August 19

- Racing updates (races run after this date will not appear in catalogue)

August 27

- Final withdrawal for horses not to appear in catalogue; second \$500 entry fee payment waived (4:30 p.m.)

August 29

- Registration certificates for all horses except weanlings due in Sales Office (\$100 penalty per horse will apply after this date)

September 4

- NTRA contribution lists in Sales Office

September 7

- Proof page changes due into Sales Office (other than those already mentioned here)

September 21

- Consignors' client lists for catalogue mailing

October 1

- Original EVA and original Coggins certificates in Sales Office (\$100 penalty per horse will apply after this date)
- Consignor's Authorized Agent forms in Sales Office (\$100 penalty per owner or property line will apply after this date)
- Stallion service certificates in Sales Office (\$100 penalty per horse will apply after this date)
- Registration certificates or copies of application for registration for weanlings in Sales Office (\$100 penalty per horse will apply after this date)

REMINDER: You must submit pregnancy certificates for broodmares and "suitable for mating" certificates for fillies 2-years-old and up being sold as
