Keeneland November Breeding Sale

Sale begins November 9, 2020

ENTRY FEE AND COMMISSION STRUCTURE

The entry fee for all Keeneland sales is \$1,000. The sales commission will be 5% on bids exceeding \$10,000 with a minimum commission of \$500 per sale. The RNA commission will be 2.5% on bids exceeding \$10,000. See below for examples of this structure at different price points:

	Breeders' Cup, EBF, KTDF and State nominations (participating states) due into their respective offices in order to appear in the sales catalogue
Aug	gust 10
	Property line changes in Sales Office.
Au	gust 16
	Racing updates (races that run after this date will not appear in catalogue)
Au	gust 24
	Final withdrawal from Sale for horses not to appear in catalogue (second \$500 entry fee waived)
Au	gust 26
	Registration certificates for all horses except weanlings in Sales Office (\$100 penalty per horse will apply after this date)
Sep	otember 4
	NTRA contribution lists in Sales Office.
	All proof page changes in Sales Office – prefer digitally returned
Sep	otember 18
	Consignors' client lists for catalogue mailing
Oct	tober 1
	Original Coggins certificates in Sales Office (\$100 penalty per horse will apply after this date)
	Original EVA results dated within 90 days of date of sale and valid until December 5 in Sales Office (\$100 penalty per horse will apply after this date)
	Digital certificates assigned to Keeneland for all weanlings (\$100 penalty per horse will apply after this date)
	Stallion service certificates in Sales Office or released electronically (\$100 penalty per horse will apply after this date)
	Consignor's Authorized Agent form in Sales Office (\$100 penalty per owner or property line will apply after this date)

REMINDER: Pregnancy certificates for broodmares and "suitable for mating" certificates for fillies 2 years old and up being sold as broodmare prospects are to be turned into the Sales Office. Pregnancy and "suitable for mating" exams must be done, and the results turned in, within 10 days of selling date.

Health Certificates are required in our office for all horses before they can sell.
