



# 2020 SEPTEMBER YEARLING SALE QUICK REFERENCE GUIDE

## Keeneland September Yearling Sale

Sale begins September 13

### ENTRY FEE AND COMMISSION STRUCTURE

The entry fee for all Keeneland sales is \$1,000. The sales commission will be 5% on bids exceeding \$10,000 with a minimum commission of \$500 per sale. The RNA commission will be 2.5% on bids exceeding \$10,000. See below for examples of this structure at different price points:

## SEPTEMBER SALE DEADLINES

### May 1

- Entries in Sales Office\*

### June 8

- Property line changes in Sales Office

### June 12

- Last day to withdraw from the sale without paying any portion of entry fee.

### June 19

- Final withdrawal for horses not to appear in catalog (second \$500 entry fee waived)

### June 22

- Breeders' Cup, EBF, KTDF and NYB nominations due into their respective offices in order to appear in the sales catalogue

### June 29

- NTRA contribution lists in Sales Office

### July 1

- Consignor's Authorized Agent forms in Sales Office (\$100 penalty per owner or property line will apply after this date)
- Registration certificates for all horses due in Sales Office (\$100 penalty per horse will apply after this date)

### July 5

- Racing updates cut-off (races run after this date will not appear in catalogue)

### July 6

- Proof page changes due in Sales Office

### July 13

- Consignors' client lists for catalogue mailing

### August 3

- Original EVA results and original Coggins certificates in Sales Office (\$100 penalty per horse will apply after this date)

*REMINDER: Health Certificates are required in our office for all horses before they can sell. E.V.A. results must be dated within 90 days of date of sale and valid until October 10.*
