



# 2021 SEPTEMBER YEARLING SALE QUICK REFERENCE GUIDE

## Keeneland September Yearling Sale

Sale begins September 13

### ENTRY FEE AND COMMISSION STRUCTURE

The entry fee for all Keeneland sales is \$1,000. The sales commission will be 5% on bids exceeding \$10,000 with a minimum commission of \$500 per sale. The RNA commission will be 2.5% on bids exceeding \$10,000. See below for examples of this structure at different price points:

## SEPTEMBER SALE DEADLINES

*\*Prefer ALL paperwork returned digitally*

### May 3

Entries in Sales Office

### June 7

Property line changes in Sales Office

### June 18

Final withdrawal for horses not to appear in catalog (second \$500 entry fee waived)

### June 21

Breeders' Cup, EBF, KTDF and state-bred nominations due into their respective offices in order to appear in the sales catalogue

### June 28

NTRA contribution lists in Sales Office

### July 1

- Consignor's Authorized Agent forms in Sales Office (\$100 penalty per property line will apply after this date)
- Digital registration certificates for yearlings due in Sales Office (\$100 penalty per horse will apply after this date)

### July 5

- Racing updates cut-off (races run after this date will not appear in catalogue)
- Proof page changes due in Sales Office

### July 12

Consignors' client lists for catalogue mailing

### August 2

- Original Coggins certificates in Sales Office (\$100 penalty per horse will apply after this date)
- EVA results in Sales Office and dated within 90 days of date of sale (\$100 penalty per horse will apply after this date)

*REMINDER: Health Certificates are required in our office for all horses before they can sell.*
