FOR THREE YEAR OLDS By subscription of \$100 each which should accompany the nomination or by Supplementary Nomination of \$4,500 by time of entry (Includes entry and starting fees), \$750 to enter and an additional \$750 to start, with \$150,000 guaranteed, of which \$90,000 to the owner of the winner, \$30,000 to second, \$15,000 to third, \$7,500 to fourth, \$4,500 to fifth and \$3,000 to be divided equally among sixth through last. Weight: 122 lbs. Non-winners of a Grade I or Grade II at a mile or over on the turf in 2021, allowed 2 lbs.; a graded sweepstakes at a mile or over on the turf in 2021, 4 lbs. The maximum number of starters for Bryan Station will be limited to fourteen, with two also eligibles. If this race is transferred to the main track the field will be limited to fourteen. In the event that the race overfills the starters will be determined at that time with preference given to graded or group stakes winners (in order I-II-III), then condition preference. Starters to be named through the entry box by the usual time of closing. (If this race is taken off the turf it will be downgraded one grade level for this running only in accordance with American Graded Stakes Committee policy). A set of two silver julep cups will be presented to the owner of the winner.
