

33rd Running Of The Coolmore Jenny Wiley \$300,000 (Grade I)

FOR FILLIES AND MARES, FOUR YEARS OLD AND UPWARD By subscription of \$150 each, which should accompany the nomination or by Supplementary Nomination of \$9,000 at time of entry (includes entry and starting fees). \$1,500 to enter and an additional \$1,500 start, with \$300,000 guaranteed, of which \$180,000 to the owner of the winner, \$60,000 to second, \$30,000 to third, \$15,000 to fourth, \$9,000 to fifth and \$6,000 to be divided equally among sixth through last. Weight: 123 lbs. Non-winners of a Grade I stakes at a mile or over on the turf since November 5, allowed 3 lbs.; a Grade I stakes at a mile or over on the turf since July 4, 5 lbs. The maximum number of starters for the Coolmore Jenny Wiley will be limited to fourteen with two also eligibles. In the event that more than fourteen fillies or mares pass the entry box, the fourteen starters will be determined at that time with preference given to graded stakes winners (in order I-II-III), then highest turf earnings in 2020-2021. Starters to be named through the entry box by the usual time of closing. Keeneland will present a trophy cup to the winning owner. A silver julep cup will be presented to the winning trainer and jockey. (If this race is taken off the turf it will be downgraded one grade level for this running only in accordance with American Graded Stakes Committee policy).
