FOR TWO-YEAR-OLDS All horses who pre-enter for the Breeders' Cup Juvenile Turf Sprint, Breeders' Cup Juvenile Turf or the Breeders' Cup Juvenile Fillies Turf are automatically nominated to this race. By subscription of \$100 each, which should accompany the nomination or by supplementary nomination of \$3,000 by time of entry (includes entry and starting fees). \$500 to enter and an additional \$500 to start with \$125,000 guaranteed, of which \$75,000 to the owner of the winner, \$25,000 to second, \$12,500 to third, \$6,250 to fourth, \$3,750 to fifth and \$2,500 to be divided equally among sixth through last. Weight 122 lbs. Non-winners of a graded sweepstakes allowed 2 lbs.; a sweepstakes, 4 lbs. The maximum number of starters for the Nyquist will be limited to fourteen. In the event that more than fourteen horses pass the entry box, the fourteen starters will be determined at that time by horses that have finished first, second or third in a graded or group stakes, then highest earnings. For Two Year Olds Under International Medication Protocol. Horses Nominated Or Entered Shall Not Be Eligible To Receive Furosemide Less Than Twenty-Four (24) Hours Prior To Post Time For The Race. Starters to be named through the entry box by the usual time of closing. A set of two silver julep cups will be presented to the owner of the winner.
