**FOR FILLIES, THREE YEARS OLD** By subscription of \$150 each, which should accompany the nomination or by Supplementary Nomination of \$7,500 by time of entry (Includes entry and starting fees). \$1,250 to enter and an additional \$1,250 to start, with \$250,000 guaranteed, of which \$150,000 to the owner of the winner, \$50,000 to second, \$25,000 to third, \$12,500 to fourth, \$7,500 to fifth and \$5,000 to be divided equally among sixth through last. Weight: 123 lbs. Non-winners of a Grade I in 2021 allowed 3 lbs.; a Grade II or \$66,000 twice in 2021, 5 lbs. The maximum number of starters for the Lexus Raven Run will be limited to fourteen with two also eligibles. In the event that more than fourteen fillies pass the entry box, the fourteen starters will be determined at that time with preference to graded stakes winners (in order I-II-III), then highest non-restricted earnings in 2021. Starters to be named through the entry box by the usual time of closing. A Keeneland trophy cup will be presented to the owner of the winner.
