

## 1st Running Of The McConnell Springs \$150,000

FOR FILLIES AND MARES THREE YEARS OLD AND UPWARD By subscription of \$100 each, which should accompany the nomination or by Supplementary Nomination of \$4,500 by time of entry (Includes entry and starting fees.) \$750 to enter and an additional \$750 to start with \$150,000 guaranteed, of which \$90,000 to the owner of the winner, \$30,000 to second, \$15,000 to third, \$7,500 to fourth, \$4,500 to fifth and \$3,000 to be divided equally among sixth through last. Weight: Three-year-olds, 122 lbs.; Older, 124 lbs. Non-winners of a Grade I stakes in 2020 allowed 2 lbs.; \$56,000 twice in 2020, 4 lbs. The maximum number of starters for the McConnell Springs will be limited to fourteen. In the event that more than fourteen horses pass the entry box, the fourteen starters will be determined at that time with preference to graded or group stakes winners (in order I-II-III), then highest earnings in 2020. Starters to be named through the entry box by the usual time of closing. A set of two silver julep cups will be presented to the owner of the winner.
