

24th Running Of The Woodford Presented by TVG \$150,000 (Grade II)

FOR THREE YEAR OLDS AND UPWARD By subscription of \$100 each, which should accompany the nomination or by Supplementary Nomination of \$4,500 at time of entry (Includes entry and starting fees). \$750 to enter and an additional \$750 to start, with \$150,000 guaranteed, of which \$90,000 to the owner of the winner, \$30,000 to second, \$15,000 to third, \$7,500 to fourth, \$4,500 to fifth and \$3,000 to be divided equally among sixth through last. Weight: Three year olds, 122 lbs.; Older, 124 lbs. Non-winners of a Grade I stakes on the turf in 2020, allowed 2 lbs; a Grade II on the turf in 2020, 4 lbs. The maximum number of starters for the Woodford will be limited to fourteen with two also eligibles. If this race is transferred to the main track the field will be limited to fourteen. In the event that the race overfills the starters will be determined with preference given to graded stakes winners (in order I-II-III), then highest non-restricted turf earnings in 2020. Starters to be named through the entry box by the usual time of closing. A Keeneland trophy cup will be presented to the owner of the winner.
