	All horses must be vaccinated against Equine Herpes Virus Type 1 (EHV-1) by a licensed veterinarian a minimum of fourteen (14) days and no more than one hundred and twenty (120) days prior to sale date. Proof of vaccination date and product used must be emailed to <i>mjohnson@keeneland.com</i>
	<ul> <li>Jockey Club Registration certificates due.</li> <li>Digital registration transferred to Keeneland Association, Inc.</li> <li>Original registration certificates turned into or mailed to Sidney Boots in Sales Office.</li> </ul>
	Stallion Service Certificates due in office to Sidney Boots or released electronically to Keeneland.

	<ul> <li>X-rays to Repository: Must be taken within 10 days of sale date.</li> <li>X-rays, endoscopic videotapes and veterinary certificates must be on file in the Repository at least four days prior to sale date.</li> <li>Veterinarians need to reach out to awhalen@keeneland.com for directions to upload x-rays into the repository.</li> </ul>
	Pregnancy certificates for broodmares and "suitable for mating" certificates for fillies 2 years old and up being sold as broodmare prospects due into the Sales Office. Pregnancy and "suitable for mating" exams must be done, and the results turned in digitally to the Sales Office, within 10 days of selling date. Please submit to <i>mhunter@keeeneland.com</i> .
