FOR THREE YEAR OLDS AND UPWARD By subscription of \$100 each which should accompany the nomination or by Supplementary Nomination of \$6,000 by time of entry (Includes entry and starting fees). \$1,500 to enter and an additional \$1,500 to start, with \$300,000 guaranteed plus an additional \$50,000 KTDF for KTDF eligible horses. After payment of 1.25% to each owner of horses finishing sixth through last, 62% of the remaining association purse will be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth. KTDF funds correspondingly divided providing a KTDF eligible horse finishes in an award position. Weight: Three year olds, 122 lbs.; Older 125 lbs. Non-winners of a Grade I at a mile or over in 2022, allowed 2 lbs.; Grade II over a mile in 2022 or \$90,000 over a mile in 2022 allowed 4 lbs. The maximum number of starters for Hagyard Fayette will be limited to fourteen with two also eligibles. In the event that more than fourteen horses pass the entry box, the fourteen starters will be determined at that time with preference to graded or group stakes winners (in order I-II-III), then highest non-restricted earnings in 2022. Starters to be named through the entry box by the usual time of closing. A Keeneland trophy cup will be presented to the owner of the winner.
