Friday, April 29

ENTRY FEE AND COMMISSION STRUCTURE

The entry fee for all Keeneland sales is \$1,000. The sales commission will be 5% on bids exceeding \$10,000 with a minimum commission of \$500 per sale. The RNA commission will be 2.5% on bids exceeding \$10,000. See below for examples of this structure at different price points:

TUESDAY, MARCH 1 – FRIDAY, APRIL 1

- Entries open

FRIDAY, APRIL 1

- Final entries due online
- Final withdrawal to not appear in catalogue
- Property line changes in Sales Office—
mhunter@keeneland.com
- NTRA contribution lists in Sales Office
- Breeders' Cup, EBF and State-bred nominations due into their respective offices in order to appear in the sales catalogue

SUNDAY, APRIL 3

- Racing updates (races run after this date will not appear in catalogue)

MONDAY, APRIL 11

- Original Coggins certificates emailed (in color) to mjohnson@keeneland.com in Sales Office
 - Coggins results must be dated within 6 months of the selling date and valid for at least two weeks after the selling date.
- EVA results emailed to mjohnson@keeneland.com in Sales Office
 - EVA results must be dated within 90 days of selling date.
 - Each positive or suspicious EVA form must contain a titer reading.
- All horses must be vaccinated against Equine Herpes Virus Type 1 (EHV-1) by a licensed veterinarian a minimum of fourteen (14) days and no more than one hundred and twenty (120) days prior to selling date. Proof of vaccination date and product used must be emailed to mjohnson@keeneland.com
- Jockey Club Registration certificates due
 - Digital registration transferred to Keeneland Association, Inc.
 - Original registration certificates turned in to or mailed to sboots@keeneland.com in Sales Office.
- Consignor's Authorized Agent form emailed to mhunter@keeneland.com in Sales Office
 - Keeneland must have an owner's signature on file for every horse consigned in the sale.
 - One partner's signature is sufficient for all partners.
 - Form must be filled out completely **and notarized**.
 - If owned in part or in total by consignor, no AA form needed.

TUESDAY, APRIL 19 – THURSDAY, APRIL 28

- X-rays to Repository: Must be taken within 10 days of sale date.
 - X-rays, endoscopic videos and veterinary certificates must be on file in the Repository at least four days prior to sale date.
 - Veterinarians may reach out to awhalen@keeneland.com for directions on how to upload x-rays in to the repository.
- Reproductive certificates must be done within 10 days of sale date.
 - All broodmare prospects must have a veterinary certificate on file stating "suitable for mating" dated within 10 days of selling date. Certificate can be emailed to mhunter@keeneland.com.

Reminder: Health certificates (for on-site horses) must be dated within 30 days of arrival on sale grounds and are required in our office prior to sell.

Please note—if a horse is consigned by an agent, the agent is responsible for supplying all necessary documents (forms, certificates, test results, etc.) to Keeneland pursuant to the consignor's contract. We appreciate your cooperation with this.
