The Lexus Raven Run

FOR FILLIES, THREE YEARS OLD By subscription of \$150 each, which should accompany the nomination or by Supplementary Nomination of \$6,000 by time of entry (Includes entry and starting fees). \$1,500 to enter and an additional \$1,500 to start, with \$300,000 guaranteed plus an additional \$50,000 KTDF for KTDF eligible horses. After payment of 1.25% to each owner of horses finishing sixth through last, 62% of the remaining association purse will be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth. KTDF funds correspondingly divided providing a KTDF eligible horse finishes in an award position. Weight: 123 lbs. Non-winners of a Grade I in 2022 allowed 3 lbs.; a Grade II or \$66,000 in 2022, 5 lbs. The maximum number of starters for the Lexus Raven Run will be limited to fourteen with two also eligibles. In the event that more than fourteen fillies pass the entry box, the fourteen starters will be determined at that time with preference to graded stakes winners (in order I-II-III), then highest non-restricted earnings in 2022. Starters to be named through the entry box by the usual time of closing. A Keeneland trophy cup will be presented to the owner of the winner.
