FOR THREE-YEAR-OLDS AND UPWARD By subscription of \$100 each, which should accompany the nomination or by supplementary nomination of \$6,000 at time of entry (includes entry and starting fees). \$1,150 to enter and an additional \$1,150 to start with \$3000,000 guaranteed plus an additional \$50,000 KTDF for KTDF eligible horses. After payment of 1.25% to each owner of horses finishing sixth through last, 62% of the remaining purse will be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth. KTDF funds correspondingly divided providing a KTDF horse finishes in an awarded position. Northern Hemisphere Three-Year-Olds, 122 lbs.; Older, 126 lbs.; Southern Hemisphere Three-Year-Olds, 118 lbs.; Older 126 lbs. Non-winners of a Grade I or Grade II race over ten furlongs in 2022, allowed 2 lbs.; a Grade III over ten furlongs in 2022 allowed, 4 lbs. The maximum number of starters for The Thoroughbred Aftercare Alliance will be limited to fourteen. In the event that more than fourteen horses pass the entry box, the fourteen starters will be determined at that time with preference to graded or group stakes winners (in order I-II-III), then highest earnings in 2021-2022. Starters to be named through the entry box by the usual time of closing. A set of two silver julep cups will be presented to the owner of the winner.
